





ATTENTION DOG OWNERS:




Simple Fix For Noisy Dog Tags



TYPES OF BURNING

Recreational Fires: Fires used for cooking or recreation. Must be 3-feet in diameter or smaller and burning only charcoal or firewood. Permits may be required-consult your local fire district.

Residential Fires: Burning of yard and garden debris, such as leaves, weeds, pruning's and garden refuse. NO TRASH BURNING! Permits may be required-consult your local fire district.

<u>Land Clearing Fires:</u> Burning of trees, stumps, shrubbery, and other natural vegetation from land clearing projects. Permits **ARE** required-consult ORCCA.

<u>Silvicultural Fires:</u> Burning of forest debris as part of woodland management projects. Permits **ARE** required-consult Department of Natural Resources.

94.1.075 What property development activities are prohibited in The Pines? No person, owner, tenant, contractor, or developer within the legal boundaries of Nisqually Pines Community Club who owns or is developing or changing the landscaping of property within the Pines shall not:

(1) General (a) Have more than one single family dwelling on each legally platted lot; 1st \$1,000 2nd \$2,500 3rd \$5,000 4th \$1,000 & consecutive offenses

94.1.040 What vehicle-related activities are prohibited in The Pines? No person within the legal boundaries of Nisqually Pines Community Club, shall:

(1) Drive vehicles not licensed for use on public streets (not street legal) on Pines streets or community property.

\$330-each offense

(12) Parking vehicles in The Pine's right-of-way in a manner that obstructs traffic, the mail carrier, or emergency equipment; or for any period exceeding six hours. Parking on The Pine's right-of-way is permitted in the residence's **DRIVEWAY** only. The vehicle must be two feet or more away from the asphalt.



Whether you are planning to use your employees or hire a contractor, start digging means calling 811 before each job. Outline your dig area in white paint so that the utilities will know where to mark. Even homeowners digging on their on property must call, if digging deeper than 12 inches.

Don't take a chance. Call 811 before you dig, then dig by hand within 2 feet of the markings.

GOLF CART ZONE INITIATIVE 2017-1



Dear Property Owners:

A few months have passed since this measure was introduced to the membership in July 2017. There was a good deal of interest in seeing this issue placed on the ballot for a vote by NPCC members in good standing.

As you may recall, signatures were collected at various locations within Nisqually Pines for about three weeks, just before the normal voting period in September. Unfortunately, we were short by seven signatures in order to place the initiative on the ballot at that time.

It is the intent of the undersigned to collect additional signatures during the months of April and May. We are allowed to use the signatures previously collected (which totaled 62) - so those members who signed last summer will not need to sign again. Signers must be the legal property owner as shown in the Thurston County tax records to qualify on the petition, and only one owner may sign per property.

Following this letter is a copy of the original *Initiative 2017-1* for your review and understanding of the requirements for a "Golf Cart Zone" as set forth in RCW 46,08,175.

PROPOSED INITIATIVE UNDER CONSIDERATION FOR CHANGE TO NPCC BY-LAWS

INITIATIVE #1-2017: Change to Resolution 94.1.040 (1) and Designation of NPCC as a "Golf Cart Zone"

Proposal to allow residents of NPCC to operate "approved" golf carts within our community, as a mode of transportation from a residence in the "Pines" to other locations such as the pool, river park, children's playground, another dwelling within the community, or any other reason that a licensed vehicle is used on our roadways. The current Washington State regulating code regarding the creation of golf cart zones is provided below for your information.

RCW 46.08.175

Golf cart zones.

- (1) The legislative authority of a city or county may by ordinance or resolution create a golf cart zone, for the purposes of permitting the incidental operation of golf carts, as defined in RCW $\underline{46.93.1945}$, upon a street or highway of this state having a speed limit of twenty-five miles per hour or less.
- (2) Every person operating a golf cart as authorized under this section is granted all rights and is subject to all duties applicable to the driver of a vehicle under chapter 46.61 RCW.
- (3) Every person operating a golf cart as authorized under this section must be at least sixteen years of age and must have completed a driver education course or have previous experience driving as a licensed driver.
- (4) A person who has a revoked license under RCW $\underline{46.20.285}$ may not operate a golf cart as authorized under this section.
- (5) The legislative authority of a city or county may prohibit any person from operating a golf cart as authorized under this section at any time from a half hour after sunset to a half hour before sunrise.
- (6) The legislative authority of a city or county may require a decal or other identifying device to be displayed on golf carts authorized on the streets and highways of this state under this section. The city or county may charge a fee for the decal or other identifying device.
- (7) The legislative authority of a city or county may prohibit the operation of golf carts in designated bicycle lanes that are within a golf cart zone.
- (8) Golf carts must be equipped with reflectors, seat belts, and rearview mirrors when operated upon streets and highways as authorized under this section.
- (9) A city or county that creates a golf cart zone under this section must clearly identify the zone by placing signage at the beginning and end of the golf cart zone on a street or road that is part of the golf cart zone. The signage must be in compliance with the department of transportation's manual on uniform traffic control devices for streets and highways.
- (10) Accidents that involve golf carts operated upon streets and highways as authorized under this section must be recorded and tracked in compliance with chapter $\underline{46.52}$ RCW. The accident report must indicate that a golf cart operating within a golf cart zone is involved in the accident.

[2010 c 217 5 4]

In addition to the mandatory Washington State rules enumerated in RCW 46.08.175 above, the following suggestion may also be necessary given the fact that "The Pines" is, in large part, a community of working people.

Golf carts are not allowed on any roadways during the hours of 6:30-7:30 am, and from 4:30-5:30 pm Monday through Friday. These are peak hours of heavy traffic in and out of the community and a golf cart may hinder flow.

A resident of the Pines (including those in a rental capacity) who desires to operate a golf cart would be required to complete an application. This form would contain the necessary information pertaining to both the "approved golf cart" and the owner. The golf cart would require inspection by a Sheriff Deputy on patrol in The Pines to ensure all safety requirements have been met.

A "Pines" decal, similar to what is required to park a vehicle in the river park, would be affixed to the rear bumper. This should be a numbered decal so that any misuse of the golf cart could be reported to or identified by our security patrol.

There are several benefits to allowing golf carts on our roads:

- Since the speed limit on all of our roads is 20 mph and the maximum speed of a golf cart is also 20 mph, the occasional use would actually help to control speeding by briefly slowing down the faster driver.
- 2. A golf cart, because of its openness, would provide the driver or passenger(s) with a better view of someone who might be attempting to burglarize a home in our community.
- Provides the opportunity to be more neighborly, as folks will usually exchange a wave and say hello as golf carts pass by in communities where they as used.
- 4. Little or no noise is created by the operation of a golf cart and therefore it would not be a nuisance to our community.
- 5. Use of the golf cart will further promote the "Purpose" of NPCC as written in the Bylaws (revised 2014) ARTICLE I (3) which states:

"The purpose of this association is to promote the community welfare of the members and their families to make The Pines a better place in which to live and enjoy life, for the benefit of members and their families".

In conclusion, this Initiative requires the signatures <u>"of members in good standing representing ten</u> <u>percent of the total votes of the association"</u> per ARTICLE II 4. e. of the NPCC Bylaws in order to be placed on a ballot and voted on by the entire membership.

If you are a property owner in favor of this initiative please sign and complete the petition roster of signatures.

Response from Sherry O'Dell Board President

- 1. Please read the law that was cited to you by the initiative supporters. It says, *a city or county* can adopt a rule about golf carts. We are not a city or county. We own our own roads. We are responsible for what happens on our roads.
- 2. These are relatively very small vehicles using the same road space as very large trucks, cars, and so on. They are particularly vulnerable. They don't even have seat belts, much less air bags. Texting, negligent, and affected drivers are a danger to everyone, but the danger is much worse to people in golf carts.
- 3. Members who want to use golf carts in Nisqually Pines are likely to be surprised when they check to see if their homeowners' or auto policies cover damages or injuries to occupants of their golf carts, or damages or injuries caused by the drivers of their golf carts.
- 4. If we do allow golf carts on our private roads, in order to meet our responsibilities to the Association, the Board would have to adopt reasonable rules and regulations. For example, no one should ever be allowed who has any amount of alcohol or mind-altering drugs in their system.
- 5. If we have rules, we have to enforce the rules. We have no traffic police. How are we going to enforce against drunk golf cart drivers? Do we need to get breathalyzers for traffic patrol officers to use?
- 6. Sheriff's deputies on patrol don't do golf cart safety checks. If we were to allow them, golf carts should all be required to be in good condition with all safety requirements met, and insured, with proof of both, and only licensed drivers should be able to drive them.
- 7. How much more do you want to pay in assessments for rules enforcement?
- 8. If we allow golf carts, we as an Association are at risk of a lawsuit if something happens on our roads and someone gets injured in or by a golf cart. If we have no rules, then we should have had rules. If we have rules, then we didn't enforce the rules. We can't win, unless maybe we have rules, and add enough assessments to afford real enforcement of those rules, and more administration in the office to manage all of this.
- 9. Golf carts may sound like a great idea, with no possible issues, but the risks of very significant liability are substantial, and the administrative burdens would also be substantial and expensive.
- 10. There should be a rule that says that truly disabled persons can use golf carts if reasonable and necessary under their circumstances, though.
- 11. Our goal is to keep The Pines safe, and keep the costs down. How many people would this really benefit, and why should everyone have to pay more for them?

Hummingbird Nectar Recipe

Here is a homemade hummingbird nectar recipe to use now that you have purchased several hummingbird feeders and decided where to hang them.

A Homemade Nectar Recipe:

- * Step 1: Bring 1 cup of water to a boil.
- * Step 2: Add 1/4 cup of white granulated sugar.
- * Step 3: Stir well until the sugar is dissolved.
- * Step 4: Boil this mixture for 2 minutes to help prevent it from spoiling too rapidly.
 - * Step 5: Allow to thoroughly cool.
 - * Step 6: Pour into a clean hummingbird feeder.

Tips:

- * Use a larger 4 parts water to 1 part sugar mixture to make a bigger batch of nectar.
 - * You can store the unused nectar in the refrigerator for 2 weeks.
- * Do not use honey as this can causes a fatal infection to a hummingbird's tongue.
- * Artificial sweeteners or sugars have no nutritional value. Please don't use them.
 - * Red dves are not necessary and some may be unhealthy.
 - * Remember to clean your feeder regularly.
 - * Change the nectar once a week and more often in hot weather.
- * NOTE: A sugar water mixture can quickly ferment in the heat and sun causing bacteria and mold.

We have been using this nectar recipe for years and we have had many hungry birds at our feeders.

We hope your feeders will be as busy with hummingbirds enjoying this delectable treat!
