


Dumpster Days

If you see a loose dog, come and fill out a complaint form with the address of the home owner and the property standards will send out a letter as a friendly reminder. If it continues the fines are as follows: 1st: \$100 2nd: \$250 3rd: \$500 4th: \$1,000

If you are a dog owner or know someone who owns a dog, please inform them it is a violation within The Pine's and Thurston County to let dog/s run loose outside unattended. There is a county wide leash law which applies to the Pine's. If your dog/sis an inside dog and you let it out to relieve itself, please keep it confined to your own yard. There are many resident's who like to go for walks and do not appreciate fending off dog/s. Nor do they like to clean up "presents" left behind by wandering dog/s. Please consider your neighbors. Thank you for being a considerate pet owner.



<u>Land Clearing Fires:</u> Burning of trees, stumps, shrubbery and other natural vegetation from land clearing projects. Permits ARE required-consult ORCCA.



Bicycle riders— please make sure your reflectors work or you have a light so you are more visible.






Car Owners- Check your front headlights, rear taillights and brake lights to make sure that they are in working condition.

Spring has arrived and you may still have plans to start construction and landscaping projects. Your friends at Puget Sound Energy want to remind you about the importance of calling 811 at least two business days prior to any digging. It is the law, and utility-owned lines are located for free.

Whether you are planning to use your employees or hire a contractor, start digging means calling 811 before each job. Outline your dig area in white paint so that the utilities will know where to mark. Even homeowners digging on their on property must call, if digging deeper than 12 inches.

Don't take a chance. Call 811 before you dig, then dig by hand within 2 feet of the markings.



Roll call of board members Cory Parsons, Sherry Odell, Roxanne Yaconetti, and Dino Ulestad Mike Cui on the phone and Alyssia Howard was absent Rules/Civility reminder

Restroom renovation: Long range plan – Get together ideas of how to upgrade restrooms- Ideas will be given to the board. The remainder of the money that cannot get done by September 30 will remain in the long range plan account and will have to be voted on again.

Clubhouse rental agreement- Clubhouse rental amounts. The clubhouse use policy and prices to use the clubhouse will change a small amount to offset the money needing to be spent to upgrade the kitchen vent and maintaining the filters and general upkeep.
