
We are currently working on the upcoming budget. We will have it ready for viewing at the picnic, and then it will go out for your vote.


Please watch for children and parent's please remind your children to watch for cars and not to block the roadways. Please slow down and watch for walkers/joggers/bikers

Bicycle riders— please make sure your reflectors work or you have a light so you are more visible.






Car Owners- Check your front headlights and rear taillights to make sure that they are in working condition.

As fall/winter approaches, you may have plans to start construction and landscaping projects. Your friends at Puget Sound Energy want to remind you about the importance of calling 811 at least two business days prior to any digging. It is the law, and utility-owned lines are located for free.

Whether you are planning to use your employees or hire a contractor, start digging means calling 811 before each job. Outline your dig area in white paint so that the utilities will know where to mark. Even homeowners digging on their on property must call, if digging deeper than 12 inches.

Don't take a chance. Call 811 before you dig, then dig by hand within 2 feet of the markings.







Unfinished business: Mailing: regarding the four page mailing of the recent audit and budget report that the finance committee requested we send out. The cost was just over \$419.00. We need to add this amount to the future budget if we continue this yearly mailing.

Pool Mural: Protective covering of the pool mural, the board agreed to pay up to \$2000.00 the total cost was: \$1576.67 The board also approved to spend up to \$800.00 to help the artist in paint and supplies to finish the mural and the total spent was \$223.67 The artist was not paid to paint this mural, this was her gift to the community. Also, the recent Nisqually Valley News did a wonderful story on our pool mural and Sarah the artist. It is so good to have the local paper share such positive news having to do with our community.

Office Policy: we need to update some parts of the policy regarding the making copies and staff availability to do that, this was covered in part on email. The board will add this possible update to the next study session.

Committee Reports:

Maintenance: Cory Parsons: interviews completed 7 applicants. All were good. Board Contacts are ready to offer the job to one person. We will give the name to the community after this person accepts the position. He will be starting this summer.

Water: issue with an old well, bumped up the other well.

River park: Tony Swy (hard to hear) Porta Potty at the river park is in bad shape from vandalism. There was discussion about moving the Porta Potty to a different spot at the park. 


