General Outdoor Burning Rules

Check Permit Requirements for your area. For instance, all fires within Thurston County require permits.

Do NOT use a burn barrel. Burn Barrels and other burn containers are illegal under state law and their use may result in fines.

Burn only natural vegetation from your own property. Trash burning is illegal and may result in fines up to \$14,915.

Check the weather prior to starting your burn. Don't burn during air stagnation events nor in windy conditions.

Fires must be attended at all times and must be completely extinguished. Do NOT create a nuisance. You are responsible for you fire. Creating smoke, odor and ash that unreasonably impacts neighbors properties is illegal.

94.1.075 What property development activities are prohibited in the Pines? No person, owner, tenant, contractor, or developer within the legal boundaries of Nisqually Pines Community Club who owns or is developing or changing the landscaping of property within the Pines shall not:

(1) General
(a) Have more than one single family dwelling on each legally platted lot;
1st offence: \$1000 2nd offence: \$2500 3rd offence: \$5000 4th offence: \$1000

Paragraph (3) Section C- Burning any garbage or toxic items:; 1st offence: \$250 2nd offence: \$300 3rd offence: \$500 4th offence: \$1000

Please remember that household furniture and garbage are not to be burned. It's a warning letter and then a fine. Also you could get a large fine from ORCCA.

As summer approaches, you may have plans to start construction and landscaping projects. Your friends at Puget Sound Energy want to remind you about the importance of calling 811 at least two business days prior to any digging. It is the law, and utility-owned lines are located for free.

Whether you are planning to use your employees or hire a contractor, smart digging means calling 811 before each job. Outline your dig area in white paint so that the utilities will know where to mark. Even homeowners digging on their on property must call, if digging deeper than 12 inches.

Don't take a chance. Call 811 before you dig, then dig by hand within 2 feet of the markings.

Burglary Prevention Tips

The Thurston County Sheriff's Office Investigative Services Division would like to provide homeowners some helpful tips to prevent burglarles. Most burglaries in Thurston County occur during daytime hours when most residents are not home between 8am - 5pm.

Burglars often drive to the residences they target and will often come to the front door and knock. If someone answers the door they will often make up some excuse for being at the location or advise they are looking for someone. If no one answers the front door they will try other doors around the residence before breaking in. Some steps you can take to help prevent burglaries:

- Report any suspicious vehicles or persons to law enforcement (360 704-2740 dispatch)
- Obtain a license plate if someone comes to your door and they don't belong there
- Have an audible alarm system that can scare off burglars and alert neighbors
- Make sure doors and windows are locked
- Place rods or wooden dowels in sliding windows and doors
- Secure window style air conditioners (This is a very common point of entry)
- Have a good Neighborhood Watch Program and have neighbors call law enforcement if they see anything suspicious
- Leave a light, radio, or TV on in the residence when you're away
- Make sure landscaping does not allow places for burglars to hide

Winter Water Safety Tips Sergeant Ray Brady

TCSO Dive Rescue Team would like to take a moment to remind the citizens of Thurston County about the dangers of our waterways. As the weather continues to get colder this winter we want to discourage citizens from being on the water without proper thermal protection and a life preserver. Stay off frozen lakes, ponds, streams and rivers. Frozen water in Thurston County is typically not capable of supporting a person's weight. Our waterways don't freeze solid enough and often have thin or weak spots near outflows, inflows, or any moving water. Take extra precautions to keep kids and pets off of frozen waterways. Have a safe and happy winter.

Winter Safe Driving Tips

The Thurston County Sheriff's Office would like to remind our citizens to be prepared for winter road conditions. We suggest that each vehicle you drive have a Preparedness kit. This kit should include, at minimum, the following:

- Blanket and or extra warm clothing
- Bottled water and non-perishable high energy foods
- Flares
- First ald kit
- Cell phone charger
- Snow chains
- Good winter tires installed on your vehicle prior to driving

When driving on wintery roads, please keep in mind these few helpful tips:

- Buckle up
- Keep your car's windows, mirrors and lights clear of snow and ice
- Allow plenty of time to reach your destination
- Brake early and slowly
- Keep a safe distance of at least five seconds behind other vehicles
- DO NOT use cruise control
- Avoid abrupt steering maneuvers
- Maintain at least a half tank of gas during the winter season.
- If necessary to pull over, make sure you are clear of the roadway

Tips to Keep Your Car From Being Broken Into

1) Never leave valuables in plain sight – This may sound obvious, but many people tend not to seriously evaluate what a thief may consider to be valuable. Many thieves will break into a car simply to steal a GPS system you may have left stuck to your window. Thieves like this often attack many cars at once, often focusing on apartment complexes or night clubs. Even the simple act of leaving a gym bag in your back seat can tantalize a thief into breaking into your vehicle. Although the bag may have nothing in it but gym clothes, they may steal the bag in hopes of finding expensive sneakers, mp3 players, wallets or other valuable items. To be as safe as possible, always put bags in your trunk, and remove your GPS from your window every evening. If your GPS uses a mounting bracket or device, try to remove that as well, just to be extra careful.

2) Always lock your doors and shut your windows – Again, most people view this as a matter of course, but many car doors remain unlocked and far too many windows are left rolled down. While most vehicles can lock all doors with the press of a button, many still require manual locking. Some vehicles have separate locking mechanisms for their trunks, as well. Many thieves choose which car they will rob based on how easy it will be to enter, and by testing door handles in parking lots looking for an open door. Do not make it easy for them to victimize you. Keep all doors and other points of entry to your car secure. This includes windows, moonroofs and, for trucks, sliding rear windows.

3) Be careful where you park – Always try to park your car in an as highly trafficked and well lit area as possible. Parking near other cars and away from dark corners of a parking lot is always a good practice. If you are parking in a garage, try to park near the security station or by the attendant's booth. If possible, try to park directly under a light post or other light source. Thieves will be less likely to commit a crime in the brightest area of the parking lot or structure they are targeting. If you are parking in an area that is new to you, always try to choose a spot in a driveway rather than on the street.

4) NEVER leave your car running and unattended – Have you ever left your car running while you ran into a gas station to pay for fuel? How about leaving the car on while you go into the Post Office to grab some stamps? One of the easiest ways a thief can steal your car is if you leave it running for them. Never leave your car running and unattended, no matter what the scenario. It only takes a couple of seconds for a thief to jump into your car and drive away with it and everything you had inside of it. There are far too many cases a year where a car is stolen in this very nature, sometimes with young children in the car at the time of the theft. To avoid becoming involved in such a horrendous incident, simply take your keys with you whenever you are unable to keep a direct eye on your vehicle.

5) Always use a security system – Security systems can be helpful for both stages of a stolen car incident – the before and the after. By utilizing visible cues of the presence of an alarm system such as flashing indicator lights or a Club on your steering wheel, the criminals will be less likely to break into your particular vehicle. Alarms that sound upon the opening of a car door and the breaking of a window are also helpful, as they can stop a criminal in between the act of breaking in and actually committing the theft. If your car is of substantial value to you, you should also consider affixing it with a GPS tracking device. These devices can assist the police in locating your vehicle within a few short hours of it being stolen. Often times the use of these devices can result in your car and possessions being returned to you exactly as you left them
